Clarifications on UCapital, the regulated ecosystem, and the misuse of the name by third parties

Milan, December 18, 2025 – UCapital24 S.p.A., a highly innovative technology company operating in the Fintech and Media sectors and listed on Euronext Growth Milan (hereinafter “UCapital24”, the “Company” or the “Issuer”), announces that it has detected the online presence of third parties not connected in any way to the UCapital Group that use similar names (including “UCapital Trading”, “Ucapitals”) and related domains, particularly in the field of online trading and unauthorized investment services. In some cases, these operators have been subject to actions by the competent authorities and to reports from users and review websites, resulting in the name “UCapital” being improperly associated with practices described as “scam” or non-compliant with regulations. In order to avoid any misunderstanding, the Company clarifies the following:

- The UCapital Group operates through an English-law holding company and a group of subsidiaries active in technology, media and financial services, including UCapital24 S.p.A. (media and technology services) and UCapital Asset Management LLP (regulated services);
- Regulated services are provided exclusively by authorized entities: UCapital Asset Management LLP is registered with the competent supervisory authority and is subject to the applicable rules of conduct, control and transparency.;
- The domain ucapital.com has been acquired by the Group to host the official UCapital platform, which combines social network features, a media platform and, where applicable, an interface to fintech services offered solely by the Group’s regulated companies. The domain ucapital.com has never been used by the UCapital Group for unauthorized trading activities or improper practices.

UCapital therefore confirms that it has no corporate, operational or commercial relationship with websites and platforms reported as “scam” or subject to measures by authorities that use similar names or domains such as “UCapital Trading”, “Ucapitals” or similar. Any online content associating the UCapital Group’s brands, names or domains with such operators results from their improper use and the consequent generation of confusion. The UCapital ecosystem is instead based on principles of transparency, regulatory compliance and investor protection. For this reason::

- The Group’s official websites clearly indicate the domains, companies within the UCapital perimeter, relevant authorization numbers and links to the registers of the competent authorities, as well as the corporate and investor information of UCapital24 S.p.A. as a listed issuer;
